IN THE MATTER OF CONSIDERATION BY THE COUNTY ASSEMBLY OF SIAYA, OF THE QUALITY IN LEARNING AND TEACHING BILL, 2015, CHILD CARE BILL, 2015, PERSONS LIVING WITH DISABILITY BILL 2015, PUBLIC NUISANCE BILL, 2015; CARRIAGE OF FOOD BILL, 2015, DISASTER MANAGEMENT BILL, 2015 AND PUBLIC WORKS BILL 2015.

Article 196(1) (b) of the Constitution of Kenya, 2010 provides that “A County Assembly shall facilitate Public Participation and involvement in the legislative and other business of the Assembly and its Committees”.

Standing order No. 121 (3) states that “the Sectoral Committee to which the Bill is committed shall facilitate public participation and shall take into account the views and recommendations of the public when the committee makes its report to the County Assembly”

SUBMISSION OF MEMORANDA/PUBLIC PARTICIPATION

The Siaya County Quality in Learning and Teaching Bill, 2015, the Child Care Bill, 2015, the Persons Living with Disability Bill, 2015, the Public Nuisance Bill, 2015, the Carriage of Food Bill, 2015, the Disaster Management Bill, 2015 and the Public Works Bill 2015, underwent the First Reading.
