GOVERNOR JAMES ORENGO ADDRESSES INAUGURAL SITTING OF THE 3RD COUNTY ASSEMBLY

In a Sitting presided over by
House Speaker, Hon. George
Okode, the Governor
underscored the need for the
Assembly and the Executive to
embrace collegiality, remarking
that intentional collaboration
between the Executive and the
Assembly will create a favourable working
environment that shall enrich development
and service delivery.

On Tuesday, 11th October, 2022, Governor James Orengo addressed the formal opening of the 3rd County Assembly pursuant to the provisions of Standing Orders 13(1) and 18(1) of the County Assembly Standing Orders.

"You, as a County Assembly, must exercise your powers robustly without let or hindrance. It is my deeply held conviction that for Siaya to reap the fruits and democratic dividends of devolution, good governance, integrity, transparency and accountability and for us to attain sustainable development, the legislative authority, which is vested in the County Assembly, must be respected, upheld, defended and protected.

I will never seek to make you an appendage of the county executive," remarked the Governor.

He further commended House Speaker George Okode for the overwhelming confidence bequeathed upon him by the MCAs to preside over the affairs of the County Assembly for the third uninterrupted term. Governor Orengo congratulated members for making it to the August House, and asked for their cooperation in enriching his vision.

In appreciation of the Assembly's oversight role, the Governor committed to ensure that all County Executive Committee Members appear before House Committees when invited or summoned.



HON. GEORGE OKODE ELECTED AS SPEAKER FOR THE THIRD UNINTERRUPTED TERM

Hon. George Okode, MBS was on Tuesday, 20th September, 2022 overwhelmingly elected as Speaker of the Third County Assembly of Siaya after meeting the threshold of two thirds of votes of all the 40 MCAs who voted. Hon. Okode resoundingly triumphed over his sole competitor Mr Evans Oruenjo by garnering 38 out of the 40 votes cast.


He is therefore set to serve as the County Assembly Speaker for the third uninterrupted term having been elected for the first time in March 2013.

The Speaker's position attracted 12 aspirants who picked nomination forms from the Office of the Clerk. Three candidates failed to submit their nomination papers while the other seven failed to meet the minimum requirements for nomination leaving the race to Hon. Okode and Mr Oruenj

In his acceptance speech the Hon. Speaker congratulated all the Members for being elected to the House and promised to accord them an impartial, accommodative and attentive environment to promote good governance as they perform their cardinal roles of oversight, legislation and representation.








Hon. George Okode shares a light moment with the Ag. Clerk Mr. Erick Ogenga after taking the oath of office

He further appreciated the Members for their trust and confidence in him and pledged to work and serve them equally without any prejudice.

"Hon. Members, your support and assessment of my capacity to lead you as your Speaker has been unanimous; I'm ready to serve you equally without any bias to your party affiliations. There will be no ODM, independent, UDM or FPK. There will be one County Assembly of Siaya and we shall walk this journey together," he stated.

The Speaker affirmed his commitment to steer the Assembly in an active oversight role in the County affairs in accordance with relevant laws and statutes.

A recipient of the Presidential Honour of the Burning Spear (MBS) and an advocate of the High Court of Kenya, Speaker Okode has previously presided over the making of over 35 county laws that are necessary for, or incidental to, the effective performance of the functions and exercise of the powers of the County Government of Siaya.

HON. ODUOR ODONGO ELECTED DEPUTY SPEAKER

West Ugenya MCA, Hon. Andericus Oduor Odongo on Wednesday, 12th October 2022 took the Oath of Office as the Deputy Speaker of the County Assembly. The race for the Deputy Speakership had initially attracted three candidates, but after soul searching, reflections and consultations, two of the candidates withdrew their candidature in favor of the Hon. Oduor Odongo.

Guided by the provisions of Standing Order Number 14 of the County Assembly Standing Orders, read together with the First Schedule of the Election Act, 2016, Speaker George Okode, in his Communication to the House, declared Hon. Odongo as the duly nominated and elected Deputy Speaker of the County Assembly of Siaya.

In his acceptance remarks soon after taking the Oath of Office, Hon.
Odongo, appreciated Members for the confidence and great responsibility they had placed on him and promised to serve the House with honour, respect and diligence.

MCAS INDUCTED ON THEIR ROLES AND EXPECTATIONS



The County Assembly undertook a weeklong induction retreat for the newly elected and nominated Members of the County Assembly.

The induction took place between 25th September to 5th October, 2022.

The training was intended to: give Members an all-round exposure of the working of a Member of the County Assembly,

- The relationship between the County Assembly and the Office of the Controller of Budget.
- The Role of the Salaries and Remuneration Commission.
- The Concept of Ethics, Integrity and Governance; Leadership and Integrity Requirements for State Officers.





KNOW YOUR MCA

Hon. Andrew Omwende

Despite his disability, the MCA elect Sigomere ward has demonstrated grit in the murky world of politics. Hon. Omwende has been active in politics for a decade. He took a first shot in politics in 2007 where he vied for a local seat and lost.

He took a second shot in 2013 in the advent of County Assemblies. He however lost the seat in 2017 to his closest rival Engineer Erick Odawa.

In the second assembly, Hon.
Omwende was nominated by ODM to represent people with disabilities.

Hon. Omwende floored Hon. Odawa during the ODM primaries and later clinched the seat on August 9th, 2022. His eloquence and deep baritone voice resonated with the residents.



He remains grateful to the people of Sigomere for trusting his leadership. He said that he was up to task and will do his best to articulate the wishes of Sigomere people.

Notable contributions as the PWD representative include championing for their rights and creating opportunities for them.

He is the brainchild of the annual sitting volleyball competition held in Ambira. The aim of the annual event is to champion inclusivity. The tournament brings PWD's from different parts of the country.

A former Paralympian Hon. Omwende says "People believe that sports are for the abled" However, he notes that sports have opened numerous opportunities. He has represented Kenya in both national and international levels.

He also notes two key figures that have shaped his thinking. He considers Ugunja MP Opiyo Wandayi, and Mama Ida Odinga mentors. They constantly challenge him to fight for what he believes in. He adds that Wandayi's development record in Ugunja is something to emulate. Hon. Omwende nonetheless notes that politics places PWDs at a greater risk due to the violence meted at them.

Hon. Gordon Onguru

Hon. Gordon Onguru alias Sultan Agodi has in the recent past hit the headlines of Siaya political land scape since his election to the County Assembly as a ward representative.

The youthful legislator hails from Kamalumbe clan in Omia malo Sublocation in East Asembo Ward



He is the eldest son in a family of four; many new him as a musician but unknown to many was his political ambition which he made public in 2022.

The musician turned legislator did not only surprise many, but his election is an inspiration to many youths. He joins the list of former musicians turned legislators such as Charles Njagua aka Jaguar.

Agodi the youthful politician aged 33 years, managed to wade through the harsh political terrain of Siaya County politics mostly dominated by the ODM party and managed to clinch the East Asembo ward MCA seat with a UDM party which came as a surprise to many. He attributed his win to prayers, hard work, his oratory skills, support by friends and fans

Education and Work Experience

Hon. Gordon started his elementary education at Powo primary school and later joined Raliew secondary school. He then advanced his education at Kisumu Institute of Management where he graduated with a diploma in community development which explains his numerous community engagement activities.



He served as a community interviewer with Kemri/CDC between 2009-2013 and later joined the County Government of Siaya as information Communication Officer for a period of one year after which he decided to join the entertainment industry.

At the Assembly, he will serve in of various key Assembly Committees including Speaker's panel, County public Investment and Accounts Committee, Sectorial Committee on Tourism, Conservation, Wildlife and Information, Sectorial Committee on lands, physical planning, Surveying and Housing.

Hon. Fredrick Odhiambo went about his normal routine as a cobbler in Masiro, Ugenya Sub County. The 47-year-old would later learn that he was nominated by ODM to represent persons with disability at the Assembly. The news came as a shocker since Hon. Odhiambo believed one must lobby to be picked as a nominee.

He was sworn on 11th October, 2022 in by the Speaker following a gazette notice. He intimated that he first set foot into the Assembly precincts during the pre-swearing in of members and never imagined he would visit the Assembly as an honorable member.

He thanked the party for making his dreams come true and added that he still hasn't come to terms to being referred to as "mheshimiwa"

He pledged to represent fully and champion the rights of PWDs. "I am one of them and I understand all that they need," he said. The nominated MCA who dropped out of school following his father's demise said he will articulate issues in Swahili. The cobbler honed his craft from a friend in order to make a living.

Hon. Odhiambo's nomination received backing from Hon. Andrew Omwende the MCA elect Sigomere ward who said that the legislator has been an ardent supporter of ODM party leader Raila Odinga and Siaya Governor James Orengo.

TERMS USED IN A LEGISLATIVE ASSEMBLY

- I. **Standing Orders**: These are rules that govern procedures of the House and its Committees.
- 2. **Order paper:** It's a daily publication in the Assembly which lists the business of the House on a particular day, published and circulated by the Table office.
- 3. **Communication from the Chair**: These are messages or rullings by the Speaker on an important matter for the Members information or on an important question asked by a Member.
- 4. **Bill:** A bill is a legislative proposal introduced to the Assembly after it has been published in the Kenyan Gazette. Bills are meant to introduce a new legislation or to a mend.
- 5. **Motion:** This is a formal proposal by a member for the House to make a decision on a matter.
- 6. **Petition**: It's a written prayer by an individual or a group of people that seeks the intervention of the House to a matter and makes resolutions with regards to the concerns raised.
- 7. **Speaker's rules:** These are rules by the Speaker to regulate conduct of members of the Assembly and orders regulating admission and conduct of visitors in the precincts of the Assembly.
- 8. Committee of the whole House: This is the entire membership of the House sitting as a committee. It only considers matters referred to it by the House which includes Bills at committee stage or budget estimates. All Bills that have received a second reading are reffered to a committee of the whole House for consideration and review
