Yes, Hon. Oriaro

Hon. Oriaro: Thank you, Hon. Speaker; it seems this day we are inaugurating our second generation Assembly in the form of a maiden speech. I want to observe before I deliberate on the subject matter. Courtesy of the 2010 Constitution; and its corollary devolution forum that regards the County Government; I want to observe that Siaya County made of its Executive and Parliamentary Arm which we are enjoying now are one engine that can only descend into Motion partly by a sound gubernatorial initiative and partly with parliamentary initiative.

And, on our side; we are blessed to be having men and women of particular. My observation is that the destiny of the Siaya public and Kenyans in ubiquity is embedded in the actions we as for now we'll opt to undertake. The burden of proof of owners probing rests with us and we must do our work. Thank you, Mr. Speaker, Sir.

Number two; as we go into the matter in question, I would observe that I am only biting the bullet; because the Motion itself is more of a lone le---but looking at the content—that is where the lives of our people squarely lies.

As we constitute the Committees; and I say by a sound parliamentary initiative; this is when Members have to prove their worth. We support the omnibus Motion with totally but with few remarks. On the aspect of Health; we all know that our Health facilities are depleted of drugs.

Requisite furniture—

The staffing aspect is in a state of equilibrium. We will also be talking about the wages we know that men and women are out on strike. It is the Committee on Health and

Privileges to be part of it. That there will be no short cut. It is the lives of our people that matter.

Because, they also have a mandate to see into it that who will be our CEO of Health will also be our Director see it et al. it is this Committee that will be tasked with ensuring that we have the correct people. We won't let a situation whereby we have someone as a CEO here and tomorrow they are no more.

This also goes to the aspects on appointment of Committees. We will not like a situation where by the Governor proposes a list today to the House today both to the House and tomorrow such a person is sacked or played around with. It will be our duty to tell the Governor off when it comes to matters of delivering of the democratic goods which are the 14 aspects as expressed in Schedule 4 where County Government must deliver, I support!

Hon. Speaker: That is Hon. Oriaro, Member for Central Alego. The speaker included is thinking that as much as we would be having a sign language interpreter we should also be coming with dictionaries to this House.

Hon. Madialo: Thank you, Mr Speaker, Sir. May I start by thanking the Hon. Majority leader for laying on the Table of this House today, a complete list that captures the names of all Members of this Honourable House as Members of various committees as required by the Standing Orders.

Mr. Speaker, I wish to observe briefly that it may not be that everybody has been allotted into a committee that would have been his/her wish to be in.
