STATEMENTS

CONSTRUCTION OF AN ABOLITION BLOCK AND PAVILION AT MIGUENA SPORTS GROUND

The Temporary Speaker: Hon. Edwin.

Hon. Odhiambo: Thank you, Ms. Temporary Speaker; I seek a Statement concerning the construction of an abolition block and pavilion at Miguena sports ground and on the same month that is on 10th I also seek a Statement on an ECDE which was built on a swampy area in my Ward.

The Statements were committed to the Committee on Education, Youth and Gender Affairs and the timeline which was given I think is over and I have not received any response from the Chairperson concerned and the entire Committee. We were expecting to Table tomorrow but since we are going to Kisumu it might not be possible we will have to Table it on our next sitting.

Hon. Odhiambo: I just want to know whether the timeline is over or not but if it's over I think they should give us the Report or they should give me a response. We have to be serious however much we are blaming the Executive we have also to be serious with our work and therefore I don't see the reason the Chair should just now lean on the recess period we are going to while this thing was given sometime back.

Hon. Adalla: Thank you, Madam Temporary Speaker; the County Assembly is a House of rules and has got its systems and agenda well laid before so a Statement once has been sent to a relevant Committee then it's their mandate to act upon it and as a Member of the Education Committee it is true that as our Chair has explained it's something that we have bottled.

This Statement has been listed for Thursday tomorrow and now the Member wants it now. I want to appeal to my colleague Hon. Odhiambo that in light of the fact that we won't be in tomorrow there is absolutely no way you are going to have it today. You will have to wait until when we resume.

Hon. Odhiambo: I think the Committee on this matter is lying to this House and I'm evening consulting with the Clerk; this Report is not yet with them and that is why; you know before I had to come to this Floor I had to consult.

Hon. Odhiambo: We have consulted.

The Temporary Speaker: Hon. Adalla; can you respond to that?

Hon. Adalla: The accurate position that we are having as Members of that Committee has been well stated by the Chair and any other thing is side chats and side shows. Odhiambo was having at home with that Clerk whom we don't even know unless it was side talks over guarana or at Ramogi hills when you are having fun but the accurate Statement has been shared with our Chair.

Hon. Olasi: Madam Temporary Speaker; I think the Chair of Education has spoken and she has said they are almost accomplishing the Report and this is a House of Rules and procedures.
