#### **STATEMENT**

PROPOSED CONSTRUCTION OF GENERAL HOSPITAL WARD AT NYAGUDA DISPENSARY IN SOUTH SAKWA WARD

**Hon. Odhiambo:**Pursuant to Standing Order 41(2)(c) I rise to seek a statement from the Chairperson Committee on Health Services on the proposed construction of a general hospital ward at Nyaguda Dispensary in South Sakwa Ward.

In the Statement the chairperson should First, explain why the department of Health in the Report dated 29<sup>th</sup> January, 2018 ref no. SYA/CHD/ASSEMBLY VOL II 201 on pending projects submitted to the Assembly Committee on Implementation reported that the said project is 75% done while the reality is that it has not yet been started

Secondly, explain why the Department of Health in their letter dated 29<sup>th</sup>, January, 2018 has reported to have spent a whooping Kshs. 1.5million on the same project and the said project is yet to commence

Thirdly, explain why the construction of the said project has delayed since FY 2015/2016 when it was budgeted for to date.

Fourthly, give concrete budgetary estimates for the project and utilization of the said funds (if any) meant for the project over the financial years

Lastly, give detailed payment details of the beneficiary accounts to which the said Kshs. 1.5 million and any other monies (if any)spent on the imaginary works on the project was made and evidences of the same.

I know you will make a ruling but I want to request the committee that this is a serious matter and it might even land some of them in King'ong'o Prisons to ensure that this is done and I want to ask the Chair if they can take a maximum of one week to give us this Report

**The Temporary Speaker** (Hon. Opanga): Hon. Abigael, are you comfortable to give a response within that time? The questions are weighty.

**Hon. Abigael:**Thank you, Mr. Temporary Speaker, Sir.In regards to the enquiry because they are 5 weighty areas we will give a response by the 11<sup>th</sup>, July 2018

The Temporary Speaker (Hon. Opanga): That is almost 2 weeks

**Hon. Odhiambo:**It was a request that if possible these things can be done within one week. If it not possible I think the 2 weeks she is giving is just proper
