NOTICE OF MOTION

REVIEWING RECOMMENDATIONS

Hon. Oor: Mr. Speaker Sir, I beg to give Notice of the following Motion:

Aware that Section 15 of the County Government Act, 2012 provides that a person has a right to petition a County Assembly to consider any matter within its authority including enacting, amending or repealing any of its legislation.

Further aware that the County Assembly on 7th November, 2016 was petitioned to intervene and address the plight of the former councilors who served the defunct local authorities in Siaya County since independence.

Noting that the Assembly considered and made recommendations and submitted to the Siaya County Executive for implementation, concerned that no action has been taken on the recommendations on benefits, among other issues raised by the Assembly. This House resolves THAT pursuant to Section 15 of the County Governments Act, 2012, the Committee on Justice and Legal Affairs review the recommendations and report back within 14 days for action.

Hon. Speaker: Hon. Willis Ochieng, MCA for West Yimbo Ward.

Hon. Willis:Mr. Speaker, I beg to give notice of the following Motion. Aware that there are enormous challenges bedeviling the fishing industry in Siaya County including but not limited to; the use of non-authorized/non-recommended fishing gears; use of poorly built and weak fishing equipment, inadequate market of fish and fish products, not to mention the constant accidents in the lake.

Further aware that the fishing industry contributes immensely to the Siaya County economic basket by offering thousands of employment opportunities, millions of shillings in terms of revenue amongst other benefits. Noting the contributions of the County Government of Siaya in the crops and dairy farming sectors of the County fisheries and Aquaculture Bill 2017 had been passed by the County Assembly, assented to but yet to be published into an Act.

Noting that there is need to provide for the sustainable utilization, management and development of fisheries, aquaculture and other aquatic resources within the County, this House resolves that the County Government of Siaya develops and submit to this House for consideration within 21 calendar day a comprehensive policy to comprehensively support the fishing gears/equipment, structured marketing and enhanced security and County law enforcement mechanisms.

Hon. Speaker: I direct that the secretariat concerned the facts behind the assenting to the Bill by the Governor and if not the Motion be amended accordingly so that we establish as to whether it is true it was assented to or the House passed the Bill but there was not assenting to it.

Hon. Siguru is giving a Notice of Motion on behalf of Hon. Ambrose Akuno, MCA West Asembo Ward.

Hon. Siguru: Mr. Speaker, Sir, I beg to give Notice of the following Motion: Aware that Section 45 of the County Government Act, 2012 provides for mandate of the Governor to appoint County Chief Officers with the approval of County Assembly. Further aware Section 64(1) of the same Act states that; *A person shall not be appointed to hold office in an acting capacity unless the person satisfies all the prescribed qualifications for holding public office,* providing conditions under which a person may be appointed in acting capacity under County Public Service Board.

Noting that Section 4 of the Public Appointments (County Assemblies Approval) Act No. 5 of 2017 provides that; An appointment under the Constitution or any other law for which the approval of a County Assembly is required shall not be made unless the appointment is approved by the relevant County Assembly in accordance with this Act. Concerned that some Chief Officers have been appointed in acting positions in the County Public Service Board.

No. 5 of 2017 provides that; An appointment under the Constitution or any other law for which the approval of a County Assembly is required shall not be made unless the appointment is approved by the relevant County Assembly in accordance with this Act. Concerned that some Chief Officers have been appointed in acting positions in the County Public Service without due regard to provisions of Section 64(1) read together with Section 45 of the County Governments Act, 2012 and Section 4 of the Public Appointments (County Assemblies Approval Act) 2017.

Further concerned that nothing stands in the way of the appointing authority in appointing substantive Chief Officers in the incident dockets and that the appointment in an acting capacity undermines expeditious appointment of competent persons to the offices as provided for in Section 64(4a) of the County Government Act, 2012.

This House resolves that all the positions occupied by acting Chief Officers be filled with substantive ones with immediate effect. Thank you.
