Hon. Adala: Thank you, Mr. Deputy Speaker, Sir, I rise to second the Motion of adjournment raised by Hon. Peter Oor whose other name is *Skumb Nyadala*

We request that we be given time to mourn today and tomorrow and get the best date for this discussion putting in mind that actually it is a very emotive Motion that we need to actually get into further details when we are very sober.

Hon. Deputy Speaker(Hon. Odongo): Yes, Hon. Adala.

Hon. Adala: Thank you, Mr. Deputy Speaker, Sir, is it in order for Hon. Otiato to stop the session while we are waiting for him to do his consultation? I think he should have done that earlier because I have a feeling that he is wasting our time.

Hon. Deputy Speaker(Hon. Odongo): Hon. Adala, I think Hon. Otiato is a Member of this House and he has the freedom to deliberate or consult before the House. I request you to be patient. Hon. Otiato you can proceed.

Hon.
