STATEMENT

CONVERSION OF SIAYA AGRICULTURE TRAINING CENTER TO BARRACK OBAMA UNIVERSITY

The Temporary Speaker (Hon. Opanga): We have a Statement response from the Chair of Agriculture, Hon. Willis.

Hon. Ochieng: Thank you, Mr. Temporary Speaker, Sir; I wish to give a response to Statement request by Hon. Francis Otiato, MCA Yimbo East Ward; conversion of Siaya Agriculture training center to Barrack Obama University.

Chair, after getting this Statement we communicated to the department of Agriculture, Livestock and Fisheries and this was the response they gave us. In response to your letter dated 15th August, 2018 ref: SCA/CORR/C.EXEC/18 VOL. XI-119 refers.

The department appreciates the Assembly's role of investigating, inquiring into and reporting on all matters relating to the mandate, management, activities, administration, operations and estimates of the department as enshrined in the Constitution 2010 and the Assembly Standing Order No. 200(5). The department will cooperate fully with the Assembly to explain any and all issues of concern raised.

The issues raised by the Honorable Member of County Assembly during the Assembly sitting on Thursday, 9th August, 2018 were:

Current occupants of Siaya ATC,

Learning activities at ATC,

Courses offered at ATC,

Conversion of ATC to a university,

Financial for budget allocation and

Fate of all training and agricultural activities originally domiciled at ATC.

The responses to issues raised are as follows; on the issue of the circumstances under which the Siaya Agricultural Training Centre (ATC) was allegedly converted into a university, I wish to state that the question does not reflect the true position of the circumstances on the ground. ATC has not been converted into a University campus within the facility and discussions towards the same are ongoing.

On the issue of the budgetary allocation from where the proposed University will be funded, I wish to indicate that the proposal being considered for the establishment of the said University campushas a financial component which can only be shared formally after the ongoing discussions for the establishment of the University within the facility have been duly exhausted and agreed on.

The tone and language of this question in the Statement are such that Hon. Francis Otiato appreciates the fact that the issue is futuristic in nature and as such no plausible answer may be given to the question at this stage until the ongoing discussions are exhausted. The County Government of Siaya signed an M.O.U for collaboration with Florida Agricultural and Mechanization University (FAMU) of USA, and is keen on pursing partnerships with other

relevant institutions and agencies as a strategy towards improving the quality and diversity of courses offered by the Siaya ATC.

On the issue of current occupants at Siaya ATC is an agricultural training institution within the department of agriculture, food, livestock and fisheries in the County Government of Siaya. The current occupants of Siaya ATC are employees of the County Government in the department of agriculture.

Learning activities are still ongoing for farmers and other agricultural stakeholders as per the functions and mandate of Siaya ATC. The courses offered are tailor-made depending on the demand of clients, students and institutions' needs. Most of the trainings offered are non-residential and there are no formal courses offered therefore there is no documented student population since trainings are offered on need basis.

The current activity taking place is upgrading ATC to increase its capacity to undertake research and other collaborative function to be able to focus on food security, extension services, capacity building, research, exchange programs among others. The upgrading will enable the institution operations and in turn make it more proactive, relevant and responsive to the desires and needs of people of Siaya and the region.

The fate of all training and agricultural extension activities originally domiciled in the institution will be decided once negotiations by the team spearheading the transformation of the institution to a university are complete.

We are not killing Agriculture but upgrading ATC to undertake and respond to more dynamic needs of the County. The new status will respond competently to the true functions as envisaged in the Fourth schedule of the Constitution of Kenya 2010.

I am persuaded to believe that this response will be sufficient to satisfactorily answer the concerns of the Honorable Member of the Assembly. Thank you.

The Temporary Speaker (Hon. Opanga): Yes, Hon. Otiato.

Hon. Otiato: Thank you, Mr. Temporary Speaker, Sir. Thank you and the committee for the response but as much as I would want to be convinced that this is the right position of things...

Hon. Olasi: Point of Order!

The Temporary Speaker (Hon. Opanga): Yes, Hon. Olasi, Majority Whip of the Party.

Hon. Olasi: Thank you, Mr. Temporary Speaker, Sir. The response we have here is signed by the acting Chief Officer of the Department. One of the areas that we as a House passed that we cannot recognize! I believe even the Mover was not in order to read this kind of response in this House. So as far as we are concerned, we cannot recognize this response in this House!

(Applause)

The Temporary Speaker (Hon. Opanga): My ruling yesterday was that as a House we will no longer recognize those who are acting until a substantive Chief Officer is appointed and they were given a period to respond. I think the Chair for Agriculture, Livestock and Fisheries through the secretariat should communicate back that the Report has been rejected. It is not recognized by this House.

(Applause)

Yes, Hon. Willis.

Hon. Ochieng: I appreciate the concern of Hon. Whip and yours, Hon. Chair that is the reason while I was reading this response, when I reached the center I was shocked! That is why I didn't read 'from the acting Chief Officer' and I was just waiting for your ruling and do the necessary. Thank you.

(Laughter)

The Temporary Speaker (Hon. Opanga): Hon. Otiato, as it stands we have not gotten the response. As a House I believe you are surely waiting for that response.

Hon. Otiato: I understand what you have said. When we made a decision as an Assembly, unless somebody thinks otherwise, the Assembly in the Act has a status of the High Court and any matter can only be appealed to a higher level not even to any other court. The decision of this Assembly once it was made, we need to move with speed on how to now stamp our authority.

Currently from this particular unofficial document you realize that when the Chairman is communicating back he should pick on these issues so that we don't waste time taking it back and then they only change the signature and bring back the same things.

The reason I was asking this question was that somebody so called acting is a political appointee...

I also wanted to get proper clarification and direction from the Committee on Agriculture, Livestock and Fisheries that are they confirming to us that there was no committee sitting to scrutinize and deliberate on the letter to the point that they should have noticed...

The Temporary Speaker (Hon. Opanga): Hon. Nick Ochola this was a response and it was sent to the secretariat and the chair was able to have it, not the committee!
