STATUS OF ECDE CENTERS INFRASTRUCTURE DEVELOPMENT IN YIMBO EAST

(iii) Explain why the Centers are not operational and the plans to ensure value for money.

(iv) Explain the plans the department has to improve the quality of operational ECDE Centers and enhance learning in Yimbo East Ward.
