STATEMENT

SIAYA COUNTY REFERRAL HOSPITAL DEBTS

Hon. Deputy Speaker: Yes, Hon. Willis Ochieng.

Hon. Ochieng: Thank you, Mr. Speaker. Pursuant to the Standing Order number 41 2(c) I rise to seek a Statement from CECM Health on the Status of and repayment plans of the threatening ballooning debts at the Siaya County Referral Hospital. Noting that the total debts the facility owes various service providers currently stands at a whopping Kshs 43,737,021. Divided among the various services as follows:

1. Dental Services: Kshs 55,000

In the Statement, the CECM should;

1. Give a detailed report on the plans the County Government has to pay off all the accumulated debts that the Referral Hospital owes to all the service providers, totaling to 43, 737, 071, and especially the recurrent expenditure, mainly Electricity, Water and Casual Wages that takes a huge chunk of the revenue of the County Hospital in rates.
2. Explain the delays in reimbursement of the Facility Improvement Fund (FIF) from the County Revenue Fund (CRF) account to the Hospital which normally interferes with operational planning and activities at the Hospital hence leading to further pending bills.
3. Give details of the plans the County Government has to avert the looming debts and crisis at the facility that has resulted into tensions including but not limited to the possibility of various creditors auctioning the facility to pay off the debts, litigations and possible termination of the supply of critical services such as Water, Electricity among others.

Hon. Deputy Speaker: I don't know if we have any Member, Finance or Health. Chair Health? Can you give us an estimate of how long you should be given? 21 working days or how many? Because we are also approaching the long recess. I don't know if you are comfortable? Hon Willis Ochieng.

I am aware that the Budget Committee is outside working on the ADP and the document that has been laid here by the Majority Leader will stand committed to the Budget Committee. I believe that the Clerks at the Table will see how the document reaches the Budget Committee. Yes, Hon. Willis?
