1. Pipeline extension from Got Matara Dua Othach Dispensary at Kshs. 1.5m
2. Pipeline extension from Chief Camp to Uyoma ECDE, Muguna Primary, Angwenyo ECDE at Kshs. 1.5m
3. Pipeline extension from Ugane, Umini and Somro at Kshs. 1.5 million
