#### STALLED CONSTRUCTION OF ECDE PROJECTS IN NORTH UGENYA

**Hon. Odhiambo:** Thank you, Mr. Speaker. Before I read the Statement, I would also like to welcome the students from Ugunja Sub County, Midhiero Secondary School. Feel most welcome to this Honorable House, and be free to ask any questions after we are finished here. Hon. Speaker, pursuant to Standing Order 41 2(c), I rise to seek a Statement from the CECM Education, Youth Gender and Social Services on stalled construction of ECDE projects in North Ugenya Ward, for Financial Year 2015/2016.

In the Statement, the CECM should;

- 1. Explain why the ECDE projects in the following schools are stalled and are exposed to harsh weather conditions risking possible destruction: Mahula, Nyamsenda and Got Nanga Primary Schools.
- 2. Explain why the Contractor abandoned the project
- 3. Explain the Plans the County Government has in ensuring the completion of the said projects as per the specifications of the BQs and within what time line. Thank you.

**Hon. Audi:** Thank you, Mr. Speaker. There is a Statement that I placed before this Honorable House, nearly 3 months ago, concerning the Status of a Dispensary in my Ward that is Lither Dispensary. That is the Health Department. Kindly ask if any Member of the Health Department can commit as to when I may get the response. Thank you.

The Temporary Speaker: Since the Member was out of order; actually when he stood I wanted to interject concerning the Statements because I had not communicated on the same but never the less the Statement that has just been read stands committed to the Committee on Education and as the norm has always been we will give you the two weeks that we had agreed for the response so that we get a response on the same.

**Hon. Odhiambo:** Hon. Temporary Speaker, Sir; I am wondering why you are on the Chair and you answer yourself. We couldn't leave the Committee Members or the Chair to respond?

**The Temporary Speaker:** Hon. Member, you are out of order, when I'm on this seat I communicate as the Chair; the Statement stands committed to the said Committee. That is the directive. I'm guided that Hon. Omwende is a Member of that Committee.

**Hon. Omwende:** Thank you, Mr. Temporary Speaker, Sir; already you have committed it to the Committee on Education but this is a very powerful Committee well known in this Assembly. I believe and trust that the Report will be dealt with in less than two weeks.

**The Temporary Speaker:** The two weeks was on the maximum.

**Hon. Audi:** Hon. Omwende; would you kindly tell us the system that you use in gauging the strengths of Committees?

**Hon. Omwende:** We already know each other and we interact even in this Assembly. It's obvious and common sense that I need not to react on...

**The Temporary Speaker:** Hon. Member you are out of order and you know the term you have used is not parliamentary. I would give you the leverage you finish but you have to withdraw the term that you have used that is not parliamentary as a second timer.

Hon. Omwende: Mr. Speaker for the sake of Hon. Members I withdraw, thank you.

**The Temporary Speaker:** He had used the term common sense, everybody here uses his senses and he has withdrawn the entire Statement.

**Hon. Oyuago:** Thank you, Mr. Temporary Speaker, sir; I have made a serious observation today in the Assembly starting from the top to the lowest that we really need a serious induction when we shall be going for recess. That's my humble plea and it should go into records, thank you.

The Temporary Speaker: Thank you but you out of order, yes Hon. Audi.

**Hon. Audi:** Mine was just a concern on a Statement that I Tabled this Hon. House 3months ago on status of Lidha dispensary. I would kindly request if the Chair or a Member of the Health Committee would inform us when we can get the response, thank you.

**The Temporary Speaker:** we are lucky we have Hon. Adala who is the Vice Chair for Health Committee, I think he can respond on that.

**Hon. Adala:** As rightly said by Hon. Shirley that some reviews need to be done in a response to the Statement that has been...

**The Temporary Speaker:** What is it, Hon. Audi?

**Hon. Audi:** May the Member tell me when we should be inquiring or is it unparliamentary to inquire?

**The Temporary Speaker:** Hon. Member, you are out of order; he was responding; Hon. Adala continue.

**Hon. Adalla:** Thank you, I meant in terms of induction and I didn't mean when to ask for a Statement which has overstayed. I basically meant on how to operate our systems so that when a request is made, the Speaker is able respond. The ICT department should rectify it so that we don't subject our Speaker to a lot of stress.

The ICT department needs to check on this so that they are able to serve us efficiently cognizant of the fact that our Speaker is technology savvy and is so much in the know. Back to the Statement by Hon. Audi; indeed, I think it has been a while and let me give an undertaking on behalf of the Committee on health; it is our wish that we are able to give a satisfactory response in this regard in the next 14days.

**The Temporary Speaker:** Hon. Member; this Statement as he alludes that it's almost a month and from my Chair and now that you are the Vice Chair and the Chair is not in you also hold the same responsibility, I direct that you communicate within 7working days on the same to the Member from today that is before we go for recess.

**Hon. Adalla:** The Temporary Speaker has already ruled and directed; the rules of the House don't allow me to contravene, however, I think that would be ambitious but we will try to do it according to your instructions.

**Hon. C. Andiego:** Thank you, Mr. Temporary Speaker, Sir; on the same note I would like to rise to know the status of my Statement I made to the Health Committee on the issue of Corona virus. As the norm...

**The Temporary Speaker:** Hon. Member, take your seat; I am very much aware of the Statement and it has not even taken two weeks. Yes, I am aware of the Statement that was moved by Hon. Wandera on the Corona status and the two weeks allocated has not yet elapsed. You will get your response on the 17<sup>th</sup> March, 2020, it's well documented.

**Hon. Oyuago:** I just wanted to clarify to our Members that in Heath department we have a crisis; we know that the chief officer is currently on leave and we are unable to engage the minister because it's the same House that sent the minister home. We are just humbly requesting Hon. Members to be patient as we wait for the chief officer or anybody else who will take the Health department.

**The Temporary Speaker:** Thank you, Hon. Member and on the same where we have an issue like that in Health; we have the County Secretary because he seats in the Cabinet and they are able to respond on the preparedness to some extend but all the same let's wait up to 17<sup>th</sup> March and if not response comes in then the department will communicate back.

**Hon. Adalla:** I only wanted to remind Hon. Shirley that the substantive Speaker who was elected by our votes while seated on that Chair was aware that this House had resolved the CEC for Health and that matters being discussed before the Court remain so and his ruling was that the Mover of the Statement redrafts it and it be directed to the chief officer who can now act on behalf of the department.

**Hon. Omwende:** Mr. Temporary Speaker, Sir; I wonder if it is right for the Member to continue discussing the same after you have given directions?

The Temporary Speaker: My ruling still stands on the one week that I had given on Hon. Audi's case on the Corona virus preparedness which is on 17<sup>th</sup> but the reason why we have said where the House had resolved on how to Move on our issues the Statement was redrafted and it's with the Committee. It's for the Committee to move with speed.
