THE SIAYA COUNTY EMERGENCY FUND BILL 2020  
(COUNTY ASSEMBLY BILL NO. 3 OF 2020)

**Hon. Madialo:** I rise to move that this House adopts the Report of the Siaya County Emergency Fund Bill 2020 (County Assembly Bill No. 3 of 2020).

In adopting this Report, I urge that the House agrees to the Bill being read a second time. This is a Bill targeted at creating a fund to address the emergencies that sometimes crop up now and again in our county.

This committee has appropriated funds for emergency funding on several occasions in the past and through various appropriations acts but those funds for lack of properly created fund accounts have not been properly utilized or have been utilized but with questions that are sometimes impossible to answer for lack of regulations pertaining to the specifications of the fund.

Siaya has seen the Covid-19 Emergency, flooding of various Wards and Sub-Counties in the recent past and where sourcing of money has been a challenge because the funds account had not been in place.

I urge the House in adopting this Report to also pass that this Bill be read a second time and that this Act becomes law subject to those amendments that might be proposed at the committee stage or Third Reading of the Bill.
