#### 1.0 Introduction:

The County Government of Siaya is desirous of decentralizing service delivery and enhancing active participation of residents of Ugunja urban area. To facilitate the decentralization, it initiated the delineation of its urban area boundary and subsequently appointed an Ad Hoc Committee. The mandate of the committee was to recommend the area for conferment of urban area status in accordance with the Urban Areas and Cities Act, 2011.

### 1.1 Composition of the Ad Hoc committee on conferment of urban areas status, Siaya County:

In line with the provisions of Section 8(2) of the Urban Areas and Cities Act, 2011 the Ad Hoc Committee was constituted as follows;

The Ad Hoc committee was supported by a secretariat drawn from the Department of Lands, Physical Planning, Housing and Urban Development which included the following officers;

George Rubiik, Maurice McOrege, Maurice Ochieng, Maureen Juma & Roseline Siangla.

It commenced its work on 16<sup>th</sup> November 2022 when it held its preliminary meeting and appointed Dr. Fredrick Owino as the chairperson. The Ad Hoc committee subsequently undertook its mandate in line with its work plan.

#### 1.2 Terms of Reference:

The Ad Hoc Committee was mandated to undertake the following tasks:

- (a) Evaluate the areas with delineated urban area boundaries against the criteria set out in section 9(3) and 10(2) of the Urban Areas and Cities Act, 2011 and
- (b) Prepare a report recommending conferment of urban area status for each eligible area for tabling before H.E the Governor, Siaya County for consideration.

#### 1.3 Methodology:

The Ad Hoc committee undertook its mandate using the following methodology:

- a. **Literature review:** The Ad Hoc Committee relied on the Urban Areas and Cities Act, 2011 and Urban Areas and Cities (Amendment) Act, 2019. It also reviewed the Ugunja urban area delineation report, the County Assembly report approving the urban area delineated boundary, the Kenya National Housing and Population Census report for Ugunja urban area for the year 2019, Siaya County financial statements, existing Land Use Plan for Ugunja and relevant information available online.
- b. **Key Informant Interviews:** The Ad Hoc Committee conducted key informant interviews. It received both oral and written responses from Administrators stationed at Ugunja.
- c. **Site visits**: The Ad Hoc Committee undertook site visits in Ugunja to assess their service levels as enumerated under the First Schedule of the Urban Areas and Cities (Amendment) Act, 2019.

#### 2.0 Status Analysis for Suitability:

The Ad Hoc committee used the eligibility criteria set out under Section 9(3) of the Urban Areas and Cities Act, 2011 and the First Schedule of the Urban Areas and Cities (Amendment) Act, 2019 for grant of Municipality Status, to assess conferment suitability.

#### 2.1 Population:

Ugunja urban area is composed of the following areas which fall within its delineated urban area boundary;

A tabulation of the population of the Ugunja delineated urban area estimates the population as **51,043** as per the 2019 Kenya Population and Housing Census report. In that regard, Ugunja satisfies the requirement for an estimated population of 50,000 which is required for grant of Municipality Status.

#### 2.2 Integrated Development Plan:

An area is eligible for grant of Municipal status if it has an integrated development plan. The Ad Hoc committee established that Ugunja urban area has a local land use plan which provides a lay out for different land uses within the area and guides development control.

#### 2.3 Revenue Collection/Potential/Capacity:

It is a requirement under Section 9(3) of the Urban Areas and Cities Act, 2011 that an area should have a demonstrable capacity or potential to generate and collect revenue to qualify for grant of Municipal status. The Ad Hoc committee established that Ugunja urban area has a wide array of economic activities which provide an avenue for own source revenue collection. The County Government of Siaya currently collects rates from the following revenue streams:

- Single Business Permit
- Parking fees
- Cess- sand harvesting, bricks and building stones
- Market levies

- Development plan approval fees
- Survey fees
- Liquor lincensing fees
- Land rates
- Entry fees for cultural sites
- Mining fees
- Hospital and Morgue fees
- Water and Sewerage fees
- Advertisement fees
- Enforcement charges
- Rent from government houses and buildings
- Fire inspection licence
- Food premises inspection fees
- Ambulance fees
- Veterinary fees

The Ad Hoc committee took note of potential revenue streams the urban area can tap into, including the following:

- Solid waste management through recycling waste for re-use.
- Fees from hire of institutional facilities.
- Pier access fees on River Nzoia (Madiwra)
- Hearse service fee
- Outdoor promotion fees
- Outdoor Catering service fee
- Value addition and legalization of the local brew (Local Gin also known as Chang'aa)
- Upscale on craftsmanship (metal works, carpentry and joinery)

It also identified potential external revenue sources the urban area can pursue to enhance service delivery such as:

- Grants from Multilateral and Bilateral Donors
- Corporate Social Responsibility (CSR) activities supported by agencies

#### 2.4 Service Delivery as per the first schedule:

An urban area qualifies for conferment of Municipality status if it has capacity to deliver essential services to its residents as provided in the first schedule. The Ad Hoc committee

established that Ugunja urban area has the capacity to deliver the following services in line with the first schedule:

#### 2.5 Active participation:

To qualify for grant of Municipality status, an urban area is required to have institutionalized active participation by its residents in the management of its affairs. The Ad Hoc committee established that Ugunja urban area had several avenues for active participation for its residents and stakeholders. There are several local radio stations in the urban area including Mayienga, Radio Nam Lolwe and Ramogi where residents can contribute to and receive information on current affairs. The area also boasts of robust associations including; Ugunja Cultural Self-Help Group, Ugunja Fish Traders, Ugunja Bar Owners Association, Ugunja Development Initiative, Tembea Youth Centre for Sustainable Development, Ugunja Northern Boda Boda Association, Ugunja Central Boda Boda Youth, Umala Widows Group and Ugunja Youth Parliament Group for sector-based engagements.

#### 2.6 Space for Expansion:

An urban area qualified for conferment of Municipality status if it has sufficient space for expansion. The Ad Hoc committee established that there are several large parcels of fallow land in the peripheries of Ugunja urban area which can be utilized for expansion. The local land use plan has also proposed areas which can be reserved for public use.

#### 2.7 Infrastructural facilities:

Eligibility for grant of Municipality status is subject to having infrastructural facilities. The Ad Hoc committee established that Ugunja urban area has several infrastructural facilities including hospitals, roads, education facilities, light industries, bus park, storm water drainage facilities and markets as evidenced from its capacity to deliver services as highlighted above in the service table.

#### 2.8 Waste Disposal:

Grant of Municipality status is considered where an urban area has capacity for waste disposal. It was a finding of the Ad Hoc committee that Ugunja urban area has a waste management structure in place which involves waste disposal in waste bins, waste collection by casual workers and disposal in a central collection site near Got Osimbo.

#### 3.0 Recommendation:

On the basis of the eligibility criteria for conferment of Municipality status as required by the prevailing legislation, the Ad Hoc committee has established that Ugunja urban area qualifies for grant of Municipality Status.

#### 3.1 Justification:

Ugunja urban area has met the minimum population requirement of 50,000 in line with the first schedule of the Urban Areas and Cities (Amendment) Act, 2019 and has satisfied the criteria stipulated under section 9(3) of the Urban Areas and Cities Act, 2011.
